Eligible Breeds:

Only purebred Silken Windhounds are eligible to enter this trial. Dogs must be one year of age or older on the date of the trial and must be individually registered with the appropriate registry.

Stakes Offered:

Open Stake – Open to hounds who have met certification requirements. Excludes ASFA Field Champions of record.

Field Champion Stake - Any ASFA Field Champion of record.

Veteran Stake – Any eligible hound whose age is at least six years, and has met certification requirements. Points go toward V-FCh or V-LCM.

Singles Stake – Any eligible hound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed. Hounds are eligible to earn TCP and CPS titles from the Singles stake.

Any exhibitor or participant who shows any sign of illness prior to or during the event will be asked to leave the trial site, and their entry fees will be refunded in full. Any exhibitor or participant unable or unwilling to adhere to the safety guidelines will be asked to leave the trial site.

Conditions of Entry:

Hounds must be one year or older on the day of the trial. All hounds will run twice, in trios if possible or braces unless excused, dismissed or disqualified. Bitches in season and lame hounds will be excused. Hounds not present at the time of roll call will be scratched after a five-minute grace period. Each entry will be examined at inspection for breed disqualifications. Hounds determined to have a breed disqualification at the time of roll call shall be barred from competition and their entry fees shall be refunded. Spayed, monorchid, cryptorchid, and neutered hounds without breed disqualifications may be entered. Regular stakes will be split if 20 or more entries are present in any one stake at the time of the draw. A penalty of \$5 will be assessed for any loose hound not competing in the course in progress.

Any hound that displays aggressive behavior during trial hours will be excused for the day


Terrain is mowed grass soccer field. Hounds need to be in top physical condition due to the high elevation. Battery powered continuous loop machine will be used and backup equipment will be available. Lure will consist of white and/or black plastic strips.

Directions to 200 West 4200 North, Hyde Park, UT:

Take I-15 north to exit 362 for 1100 S St toward US-91/US-89, slight right onto the ramp to Brigham City/Perry/Logan. Follow Logan Main Street north and turn left onto 4200 N/Bullock Rd.

Course Plans:

Saturday's course is 600 yards and Sunday's course is 605 yards, reversed for finals and BOB direction is at the discretion of the judges. USRCC reserves the right to change the course design to maintain safety or to accommodate field conditions.
